## **Guidelines:**

- A. Honoraria will not be paid to the President when acting as a Board member.
- **B.** Only one honorarium per day can be claimed by any individual. The greater of the two amount will be paid.
- **C.** Board Honoraria Schedule

- 1. The Chairman or person acting as chair shall be paid:
  - a. a stipend of \$150.00 per month,
  - b. \$140.00 per meeting of the Board or its committees, and
  - c. \$15.00 per hour spent traveling to and from meetings of the Board or its committees; the time spent is calculated by dividing the distance traveled by an average speed of 90 kph.
- 2. A member who is chairing a Board committee shall be paid:
  - a. \$120.00 per meeting of the committee, and
  - b. \$15.00 per hour spent traveling to and from meetings of the committee; the time spent is calculated by dividing the distance traveled by an average speed of 90 kph.
- 3. A member shall be paid:
  - a. a stipend of \$75.00 per month, or \$100.00 per month in the case of the Vice Chair,
  - b. \$105.00 per meeting of the Board or its committees, and
  - c. \$15.00 per hour spent traveling to and from meetings of the Board or its committees; the time spent is calculated by dividing the distance traveled by an average speed of 90 kph.

## Note: "Board meetings" include business meetings, committee meetings, conferences, retreats (with Board approval) and workshops, but not including ceremonial events. (Reference: December 10, 1998 motion 103-98)

- **D.** Community Education Committees (CECs) Honoraria Schedule
  - 1. CEC members shall be paid:
    - a. \$60.00 for CEC meetings,
    - b. \$110.00 for Council of Community Education Committee (CCEC) meetings for a full day, or \$40.00 for a portion thereof,
    - c. \$60.00 for sub-committee meetings for up to and including 4 hours (not including travel time), or
    - d. \$110 for sub-committee meetings of over 4 hours (not including travel time).
- **E.** Board and CEC members shall be entitled to be paid traveling and living expenses as though they were College employees.
- **F.** Non-employee members of other committees established by the College may be paid on the same basis as CEC members.
