**TRANSFERABILITY:** Any provider approved by Alberta Apprenticeship and Industry Training. Students must achieve a minimum of 65% cumulative weighted average for the program's courses, with an overall final exam mark of 65% or higher with no course below 50% in order to achieve successful completion for AIT's standards. Please note: You MUST receive a 70% passing mark on your AIT Period Final Exam to pass your period of training.

**PROGRAM DELIVERY:** Traditional classroom setting with shop, lab practical applications and demonstrations.

**ADMISSION REQUIREMENTS:** Must have successfully completed Carpentry Apprenticeship Second Period and be eligible through Alberta Apprenticeship and Industry Training (AIT). Must be registered as an apprentice with Apprenticeship & Industry Training (AIT) in the appropriate period of training. **INTERNATIONAL APPLICANTS:** To apply for a trade program, applicants must be a Canadian citizen or Landed Immigrant.

**EMPLOYMENT OPPORTUNITIES:** Most carpenters are employed by general contractors, are self-employed, or do construction or maintenance work for government agencies, utility companies, or manufacturing firms. Employment prospects for carpenters vary considerably depending upon the sector or type of employer. Journeyperson wage rates vary, but generally range from \$25 to \$38 an hour plus benefits. The carpentry trade can be a stepping stone to unlimited possibilities. Carpenters may advance to foreman, subcontractor, construction superintendent, or contractor. They are involved in every phase of construction, and create the base buildings that most trades will follow in the construction cycle. This overall knowledge is an advantage when applying for supervisory positions.

- **APPRENTICESHIP EXAM:** Applicants needing admission requirements must call the **Alberta Apprenticeship & Industry Training** office nearest to their location to make arrangements for writing the Apprenticeship Entrance Exam. (1-800-248-4823)
- **APPLICANTS:** for the apprenticeship program must be registered with **Alberta Apprenticeship and Industry Training (AIT)**. Application forms can be downloaded from the Alberta Apprenticeship & Industry Training (AIT) website, [www.tradesecrets.gov.ab.ca](http://www.tradesecrets.gov.ab.ca).
- **ACCEPTANCE:** Applicants who meet the requirements will be accepted and offered a space in the next available offering of the program. In some cases, the spaces at a specific location may be full and accepted applicants will be placed on a waitlist. These applicants will be accepted in the order of "first qualified, first served" should any seats become available. Applicants will receive a letter informing them of their acceptance status.
- **FUNDING:** Applicants are encouraged to check on **funding options early (minimum of 2 months prior to program start date)**. AIT offices or NLC counsellors can assist with identifying funding options and applying for sponsorship of fees and living costs.
