4.1 2020-2021 Financial Statements

Executive Director, Finance Services Sergey Semagin reiterated highlights from the 2020-2021 Financial Statements presented to the Audit & Finance Committee. Highlights include:

- All requests made by the Office of the Auditor General were fulfilled
- No recommendations or observations were made

Statement of financial position saw an increase in capital assets from \$53.4 million to \$59.7 million. This increase of \$6.3 million was due to construction of the High Prairie Campus. Northern Lakes College still maintains a healthy cash and investment balance.

Operating surplus is \$3,768K which is an increase from \$990K for the 2019-2020 fiscal year. The main reason for this increase is a reduction in spending from the approved budget due to the COVID-19 pandemic.

4.3 Public Sector Compensation Transparency Act

President Glenn Mitchell spoke to the Public Sector Compensation Transparency Act. Highlights include:

- Act came in to effect December 11, 2015
- Public sector employees and Members of the Board are required to publicly disclose compensation
- Disclosure is required and shall include, names, positions, compensation, non-monetary benefits and severances where applicable that exceed the \$136,805 threshold on June 30, 2022
- Extenuating circumstances of Members of the Board or employees where disclosure would put their safety at risk may apply for a personal exemption.
 - Exemption deadline is November 1, 2021 for the June 30, 2022 disclosure.
- Compensation disclosures will be posted on the Northern Lakes College website on or before June 30, 2022.
