Policy Statement:

The Board of Governors directs that Ancillary Services not unduly contribute to the general operating costs of delivering learner services. The Board shall receive semi-annual operating and financial services for each ancillary service, and will annually evaluate their performance.

Objective:	To ensure that learner services are not negatively impacted by the delivery of ancillary services and the cost of ancillary services delivery are reported to enable evaluation of the services
Guidelines:	Senior Leadership shall prepare semi-annual operating and financial statements for ancillary services and present to the Board.
Definitions:	Ancillary Services are goods and services provided by the College to students, staff, and others that are not core to the academic training of students but may support students, staff, and community. These services may be provided for a fee and the fee will be determined by such factors as cost to provide goods and services, market value, financial means of the customer and other relevant social factors.
