Prior to recommending the opening of a campus, the President will give due consideration to:             <ol style="list-style-type: none"> <li>A. the sustainability of funding and enrollment,</li> <li>B. the availability of adequate space,</li> <li>C. the effect on currently operating programs and services,</li> <li>D. the need for part time programs or courses,</li> <li>E. the availability of facility services,</li> <li>F. the availability of information technology support services,</li> <li>G. the availability of counselling and Continuing Education &amp; Corporate Training services,</li> <li>H. the establishment of a Community Education Committee, and</li> <li>I. the availability of alternative sources of programs and services.</li> </ol> </li>   <li>3. Prior to recommending campus status change, the President will consider:             <ol style="list-style-type: none"> <li>A. campus probationary status for a five-month term to assist with recruitment,</li> <li>B. sustainability of enrollment in full time programs,</li> <li>C. cost per full load equivalent,</li> <li>D. input from the Community Education Committee,</li> <li>E. need for full time and part time programming,</li> </ol> </li> </ol>

	<p>F. availability of alternative sources of programs and services,  G. services delivered from that campus to other sites, and  H. community commitments.</p> <p>If a decision is made to reduce the level of service at a campus due to low enrollments, the College will make reasonable efforts to provide the services of a Community Access Point (CAP). The CAP will offer part-time students access to programs and support services.</p>
