## **Policy Statement:**

The Board of Governors recognizes public participation is a critical component of the development, growth, and future of Northern Lakes College. The Board of Governors will support such participation through the authorization of honoraria paid to all Board of Governor and primary advisory body participants, in accordance with the honoraria schedules.

Objective:	To ensure those appointed to the Board of Governors, Council of Community Education Committees, and Community Education Committees are supported for their participation through the administration of honoraria for their contribution of time and expertise.
Guidelines:	<ol> <li>Honoraria will not be paid to the President &amp; CEO when acting as a member of the Board of Governors.</li> <li>Only one honorarium per day can be claimed by any individual. In the event more than one meeting is held in a day, the greater of the two amounts will be</li> </ol>
	<ul> <li>paid.</li> <li>3. Board Honoraria Schedule</li> <li>A. The Chairman or person acting as chair shall be paid: <ul> <li>i. a stipend of \$142.50 per month,</li> <li>ii. \$85.00 per meeting of the Board of Governors or its committees that are 4 hours or less, and \$170.00 per meeting of the Board of Governors or its committees that are over 4 hours, and</li> <li>iii. \$15.00 per hour spent traveling to and from meetings of the Board or its committees; the time spent is calculated by dividing the distance traveled by an average speed of 90 kph.</li> </ul> </li> </ul>
	<ul> <li>B. A member who is chairing a Board committee shall be paid: <ol> <li>\$75.00 per meeting of the committee that is 4 hours or less, and \$150.00 per meeting of the committee that is over 4 hours, and</li> <li>\$15.00 per hour spent traveling to and from meetings of Board or its committees; the time spent is calculated by dividing the distance traveled by an average speed of 90 kph.</li> </ol> </li> </ul>

	C. A member shall be paid:
	<ul> <li>i. a stipend of \$71.25 per month, or \$95.00 per month in the case of the Vice Chair,</li> </ul>
	ii. \$65.00 per meeting of the Board of Governors or its committees that
	are 4 hours or less, and \$130.00 per meeting of the Board of Governors
	or its committees that are over 4 hours, and
	iii. \$15.00 per hour spent traveling to and from meetings of the Board or
	its committees; the time spent is calculated by dividing the distance
	traveled by an average speed of 90 kph.
	4. Community Education Committees Honoraria Schedule
	A. CEC members shall be paid:
	i. \$60.00 for meetings,
	ii. \$110.00 for Council of Community Education Committee meetings for a
	full day,
	iii. \$15.00 per hour spent traveling to and from meetings of the
	Committees; the time spent is calculated by dividing the distance
	traveled by an average speed of 90 kph.
	5. Board of Governors and Community Education Committee members shall be
	entitled to be paid traveling and living expenses as though they were College employees.
	6. Non-employee members of other committees established by the College may be
	paid on the same basis as Community Education Committee members.
	7. Members of the Board of Governors, Community Education Committees, and
	Council of Community Educations Committees may opt to transfer any or all of
	their portion of honoraria back to a Northern Lakes College student award.
	8. Members of the Board of Governors who are current employees of Northern
	Lakes College will not receive honoraria as prescribed in this policy for Board
	meetings that occur during standard hours of work when the College normally
	provides compensation. Members of the Board of Governors who are also
	employees will be eligible for the monthly stipend as prescribed-and travel
Definition	honoraria as it occurs outside of standard working hours.
