3. PROGRAM REVIEWS:

3.1 Program Proposal - Rehabilitation Assistant - New

Dean Vanvelzer, the Associate Dean, Health, Human Services & University Studies, explained that it's a two-year diploma program with a certificate exit option. The first-year, students take five common courses and complete one of the specializations: Physical Therapy, Occupational Therapy, or Speech-Language Therapy. Students can graduate in the first year with a certificate in their chosen specialization or complete a second year to learn all three disciplines and graduate with a diploma. There is a practicum portion in the second year.
