Objective:	The College is committed to the health and safety of employees, students and other stakeholders.
Guidelines:	1. The Board of Governors endeavors to provide a hazard free work and learning environment by adhering to all relevant Alberta health and safety legislation. Additionally, the Board of Governors strives to promote and maintain the highest degree of physical, psychological, and social well-being of all members of the College community. To this end, Occupational Health and Safety shall be a primary objective in every area of operation within the College.
	2. Management will provide competent leadership by adhering to the Alberta Occupational Health and Safety Act, Regulation, and Code. Management will ensure that all employees review and acknowledge the current college formal Hazard Assessment, as well as any other relevant safety documentation, to maintain a safe working environment in compliance with provincial safety legislation. Additionally, they will inform employees of any known health and safety hazards in the area in which they are performing their primary work duties. Management will also ensure that all members of the College community are made aware of, and will comply with all applicable provincial legislation concerning health and safety.
	3. To meet this commitment, all Northern Lakes College employees are responsible and accountable for maintaining a healthy and safe working and learning environment for themselves and their colleagues.
